GOALS ARE TO PROVIDE ARTS INSTRUCTION TO REDUCE GANG INVOLVEMENT AND JUVENILE DELINQUENCY DURING THE CRITICAL AFTER-SCHOOL HOURS, AND TO PROVIDE YOUTH WITH A SAFE HAVEN.
